GUIDE TO BOROUGH SERVICES

Hours: Monday through Friday – 8:00am to 4:00pm

TRASH COLLECTION – Trash is collected two days per week in the borough: Mondays and Thursdays. Recyclables are also collected on Mondays and Thursdays; however, each household has only one recycling day per week. Please contact the Borough to determine which day your recyclables are collected. Trash cannot be placed at the curb any earlier than 6:00pm the day before collection.

SANITATION FEES – Sanitation fees for trash collection are included in the County/Borough tax bills. County/Borough tax bills are mailed for March 1st delivery each year. For more information, please see “Tax Bills” section below.

- The fee for collection and disposal of refuse from residential properties is \$289.25 per year, per dwelling unit.
- The fee for collection and disposal of refuse from commercial properties is \$590.00 per year, per commercial unit.
- The Sanitation fees are billed to the owner listed on the recorded deed for the dwelling unit/units.
- One bulk item may be placed out each collection day.
- For the disposal of refrigerators, air conditioners or any freon appliance, call Borough Hall to set up an appointment.
- Recyclables will be picked up on Monday or Thursday (as scheduled). Please tie or bag your newspapers.
- If your pickup day falls on a holiday, it will be picked up the following business day.
- Leaf Collection: Residents are not to rake or blow leaves to curbside. Residents have the option to utilize the Morrisville Borough Leaf Drop-off each Fall (located at Delaware & Riverview Avenues); or bag leaves for pick-up on regular trash days.
- A “leaves only” collection is held in the Fall of each year, at which time leaves must be placed in paper bags or trash cans, to be picked up separately on specific dates, NO PLASTIC BAGS. The dates for this collection are posted on the Borough website, the Government Access Channel and in the kiosks outside at Borough Hall.

WATER/SEWER BILLS – Water and sewer bills are mailed out quarterly. Checks are made payable to MMA (Morrisville Municipal Authority). The MMA also does maintenance on water mains and related infrastructure (street valves, hydrants, laterals between mains and curb stops, etc.). Some parts of the system are over 100 years old (not just in Morrisville - many areas in the Northeastern U.S.). Rather than raise rates for the customers that have lower usage, we reduced the water charge for those using less than 5,000 gallons per quarter and have put in place a uniform metering charge for all users. If you have other questions about your water or sewer service, contact the Morrisville Municipal Authority (MMA) at Borough Hall.

TAX BILLS – County/Borough tax bills are mailed for March 1st delivery. There are three payment options: Discount (if paid before the face rate due date); Face Rate (if paid on time before penalty due date); and Penalty Rate (if paid after face due date). School tax bills are mailed for July 1st delivery. There are four (4) payment options: Discount (if paid before the face rate due date); Face Rate (if paid on time before penalty due date); and Penalty Rate (if paid after face due date); and three (3) equal installments provided you have applied for and were approved for the Homestead Exclusion.
