Ms. Smith asked, is there any other nominations for that? Any other nominations?

Ms. Kronnagel stated, just quickly, this was also a last minute addition, can we get an explanation for this as well?

Ms. Smith replied, there's a lot of places that do nominations for adding extra attorneys, whether it be for if you need them for Special Counsel, labor or anything else that you would need. You don't use them unless you have to use them, it's always easier to do at the time that you are re-organizing if you're going to do it. I know some Townships have 3 or 4 engineers according to what they are going to use them for.

Ms. Kronnagel asked, so we don't have any specific reason, designation for this Special Counsel?

Ms. Smith replied, I think it's a good thing to have on staff. We have several contracts and things coming up so if we do need extra legal.

Ms. Kronnagel stated, I'm not sure if I understand the difference between the Solicitor and the Special Counsel. Is the Special Counsel something that's going to be spelled out?

Ms. Smith replied, you can use them for special labor. Let's say Mr. Flager's firm isn't able to handle several things at one time and you need to bring in extra Counsel, we will be able to do that. You can vote or not vote for it Ms. Kronnagel.

Ms. Kronnagel replied, I'm just asking for what that is. If we need it, we need it.

Ms. Smith replied, you can do it at another time. I just chose to do it at the re-organization.

Ms. Kronnagel replied, because it's new that's why I'm asking for an explanation.

Ms. Smith replied yes it is, yes. Can we do a roll call on that, please?

Motion carried by roll call vote, 8-0.

Motion 6H - Motion to appoint Borough Building Inspector/Zoning Officer/Fire Inspector/Code Enforcement Officer.

Motion to nominate Keystone Municipal Services made by Mr. Yager.

Motion carried by roll call vote, 6-2. (nay votes being Ms. Kronnagel and Mr. Parker)

Ms. Smith asked if there was anyone who wished to speak for public comment.

HEARING OF THE PUBLIC

Audience members interrupted.

1. Nancy Sherlock - 424 West Bridge Street She stated, comments already. Good Evening everyone, Mayor, newly elected, and those that have been already seated. Tonight is a night for celebration and I do congratulate those who have been re-elected, Mayor Dave Rivella and Corryn Kronnagel and also the newly elected Councilpersons, Ms. Dreisbach, Mr. Yager and Justin Bowers. Also I'd like to mention as the Judge mentioned earlier this evening, the Row Offices in Bucks County were sworn in this morning and that was Judi Reiss, who is our new Prothonotary, we have Milton Warrell our Sheriff. District Attorney, Matthew Weintruab, Controller, Neale Dougherty and Recorder of Deeds, Robin Robinsion. So congratulations to them as well. This election did not turn out the way some had hoped, but I absolutely believe in the process, and I do believe that majority rules, so congratulations to all. What I would like to mention though is the paper said that this is a 4-4 split, four Democrats, four Republicans, I'd just like to correct that because I do believe that two of our Republicans or two of our Democrats do not believe in the Democratic principles.

Audience members interrupted.

Ms. Sherlock stated, I'm not sitting down, it's my time to speak. I have the right to speak.

Ms. Smith stated, point of order.

Ms. Sherlock asked, excuse me?

Ms. Smith replied, no I just said point of order, you can speak.

Ms. Sherlock stated, thank you very much. Yes, I mean — I wasn't going to point out things this evening, but it seems that the crowd here doesn't believe it. So, I mean — we have instances, I will bring it up at another time, because tonight is not the night to bring it up, but I can bring up certain things that both Mrs. Dreisbach and Mr. Yager who are registered Democrats —

Audience members interrupted.

Ms. Sherlock stated, excuse me. Wow, anyway, there's been talk about outsourcing the Public Works. I would just like this Council to please consider doing such a thing. I don't think it's necessary. You have a small skeleton crew who is doing quite a bit as we speak. And also, these are people that live in town, pay taxes in town, have families in town. I'd like you to certainly reconsider before you make any movement towards outsourcing that. Now for some more moans and groans, another thing I'd like to bring up is the event that took place on Friday, December 22nd when Mrs. Smith came into the Borough Hall to speak to Mr. Sooby, it was during - they have a small Holiday gathering, and she asked to speak to him and she had him in the office for about and hour and a half I understand and during that time she told him that he would not need to come back, that he was done on the 31st of December. So, while I — there are so many things wrong with that, while it was inappropriate, it was unprofessional, the timing is ruthless. I don't understand the purpose behind coming in on the 22nd to tell him that. You can't just sweep the Borough Manager under the rug, it should have been done in public. And you can't just make that decision, come in and tell him don't come back, and also that we are planning on doing interim and we'll hire somebody in the future. Normally, your Borough Manager is interim and works, that's not sort of the transition that should have taken place. So I think that it was — I just think it was absolutely inappropriate.

Audience members interrupted.

Ms. Sherlock stated, I would appreciate it — you know, I'm not going to talk when other people are talking, so it would be nice if we didn't have these comments on the side — you may not like what I have to say but what I have to say a lot of it is actually the truth, you might not believe it, but it is the truth. I think the public needs to know and I'm just here to tell them. The paper was wrong, okay. That's what I'm trying to tell you. The position of Councilperson is one of honor and I know that all of you are trying to do the best you can in your own particular way, but it's not about titles, it's not about power, it's about doing what's best for the health and the welfare of the Borough.

Audience members interrupted.

Ms. Sherlock stated, I think I'll just end it with that because we have a very inappropriate audience here and once again, the bar has been lowered. Thank you and have a good evening.

Ms. Dreisbach stated, may I respond?

Ms. Sherlock stated, I was told I forgot my name and address, Nancy Sherlock, 424 West Bridge Street.

Ms. Smith stated, thank you, Ms. Sherlock.

Ms. Sherlock stated, I'll wait for the eggs apparently.

Ms. Smith stated, thank you.

Ms. Dreisbach stated, I have plans for —

Ms. Smith stated, I'm not even going to address those issues. This isn't the time and the place for it. This is a time for celebration of all the newly appointed people who are standing up here, so I will leave it at that. I look forward to working with everyone. It's a new time for Morrisville and let's move it forward and do some good things. I think we've got some good people up here, we're trying our best with it. If we make a mistake, believe me, we're the first ones to admit it and correct that mistake. So let's all get on that same path and do some good things. Congratulations everybody.
