Discussion of two Proposed Preliminary Budgets; option “A” and option “B” for the 2022 fiscal year took place regarding the budget.

Motion 4D – Motion to pass a Resolution of Borough Council of the Borough of Morrisville authorizing the Borough Solicitor to petition the Bucks County Court of Common Pleas to allow the Borough to Levy a Tax Exceeding 30 Mills in order to balance the General Fund.
